

Today, Sheriff Thomas E. Mills announces the arrest of three Delaware County drug dealers Thursday afternoon on Sealed Grand Jury Indictment Warrants issued earlier that day, concluding two separate investigations conducted by members of the Delaware County Sheriff's Office Criminal Investigation Division, between September 2014 and January 2016.




Deputies and Investigators arrested 42 year old Jenny L. Bowers of Main Street, Delhi, on a Sealed Grand Jury Indictment Warrant charging her with two class B felony offenses of Criminal Sale of a Controlled Substance in the Third Degree and one class B felony offense of Criminal Sale of a Controlled Substance in or near School Grounds. Bowers is accused of selling heroin in the Village of Walton on two occasions during September, 2014, which included the sale of heroin within one thousand feet of the Townsend Elementary School grounds on one occasion.

Adam G. Green, 37, of Griswold Street, Walton, was arrested on a Sealed Grand Jury Indictment Warrant charging him with two class B felony offenses of Criminal Sale of a Controlled Substance in the Third Degree. Green is accused of selling heroin in the Village of Walton during September 2014 and April 2015. Green was arrested at the Delaware County Correctional Facility where he is currently being held in lieu of \$150,000 cash bail as a result of his arrest Tuesday afternoon by Sheriff's Investigators on three class B felony charges of Criminal Possession of a Controlled Substance in the Third Degree.



Also arrested on a Sealed Grand Jury Indictment Warrant was 26 year old Frank W. Mastrococco of Mead Street, Walton. Mastrococco was charged by a Grand Jury with three class B felony offenses of Criminal Sale of a Controlled Substance in the Third Degree. Mastrococco is accused of selling heroin in the Village of Walton on three occasions during January, 2016. Investigators also seized in excess of \$700 cash from Mastrococco at the time of his arrest.

Previously, on November 30, 2012, Sheriff's Investigators arrested Frank W. Mastrococco on a Sealed Grand Jury Indictment Warrant charging him with three class E felony offenses of



Criminal Sale of Marihuana in the Third Degree. Mastrococco subsequently plead guilty to one count of Criminal Sale of Marihuana in the Third Degree and was sentenced to five years of probation supervision. Mastrococco subsequently violated the terms of his probation in 2014 which resulted in his probation being revoked and Mastrococco being sentenced to a one year term of imprisonment in the Delaware County Correctional Facility.

All three suspects were arraigned in Delaware County Court before Judge Richard D. Northrup, Jr., and were remanded to the Delaware County Correctional Facility without bail.

Deputies and Investigators were assisted by members of the Delaware County Probation Department and Walton Police Department in the apprehension of Bowers and Mastrococco on Thursday afternoon.

Undersheriff Craig DuMond remarked, “Although our investigators believe the arrests of these drug dealers, as well as the drug arrests they made on Tuesday afternoon, will have a significant impact on the immediate availability of heroin in the Walton area, our investigators will remain relentless in removing these businessmen from our communities...these dealers need to understand they better get out now or they will end up in prison where they belong”.
