





 considered adverse affect















Site 7 Turning Radius DPW Plow Truck






Site 7 Turning Radius Low Boy Trailer






Site 7 Turning Radius WB-67 to Loading Dock






Site 7 Turning Radius WB-67 to Salt Barn






Site 7 Cross Section - West



EXISTING SITE CROSS SECTION - WEST SCALE: 1' = 50'0' 1' = 5'-0' VERT.




Site 7 Cross Section - Mid

Environmental Impact Summary

- Site # 3 Limited Impacts to: Wetlands, Archeology, Agricultural, Streams/Water Bodies
- Site # 7 Moderate impact to: Floodplain
- Site # 9 Limited Impacts to: Archaeology, Agricultural, Threatened Species
- Site # 11 Limited Impacts to: Steep Slopes, Archaeology



Hybrid Site Option

Sites # 7, # 11 plus Site # 13 on Route 28 in Delhi

- Rather than relocate all Existing DPW operations to a single site, Wendel was directed by the DPW Committee to prepare a Hybrid Option that distributed the Program to three (3) sites as follows:
 - <u>Site # 7 (Existing Site):</u>
 - Relocate DPW Administration plus Elections, VA and OET to a new two (2) story building to the northwest corner of the site (out of the flood plain) at the intersection of Main Street and Bridge Street
 - Construction a small structure to allow continued Oil Water Separator pump-outs from other DPW facilities to be discharged into the Village sanitary as currently permitted
 - Existing DPW Administration plus Elections, VA and OET would be maintained in their current location temporarily, but demolish and remove structurally compromised existing Patrols Building
 - Site # 13 (Route 28 in Delhi):
 - Construct an approximately 16,000 SF structure, salt shed and fuel depot for two (2) Road Patrols in Delhi
 - Site # 11 (Bishop Site):
 - Construct the balance of the DPW program including heavy and light maintenance, sign and guiderail shops, storage and parts, etc. plus a fuel depot and
 - Provisions for a future salt shed, bridge fabrication shop and additional Road Patrols space
